Satisfactory Instructional Practice Performance in the Subject	Satisfactory Instructional Practice Performance in the subject conducted by the supervisor within the past year using the district performance assessment system. Highly Effective = 80 points Effective = 60 points Needs Improvement, Developing or Unsatisfactory = 0 points	
Approved Professional Development in the Subject	Professional development activities must increase the teacher's knowledge of the subject and be aligned to state standards in the subject. The training must have been completed within the last three years. 10 In-Service Credits = 10 points, 40 Points Maximum	
College Level Coursework in the Subject	College level course(s) in the subject. Semester Hour = 10 points, 40 Points Maximum
